



## Privacy Policy

CF, Inc. dba Culinary Farms is committed to ensuring that your privacy is protected. We developed this Privacy Policy, which covers how we collect, maintain, and use information voluntarily provided by you, to demonstrate our commitment to fair information practices and protection of your privacy. Please take a moment to familiarize yourself with our Privacy Policy and let us know if you have any questions.

### What We Collect

**Information you give us.** You do not need to provide any personal information to access our website; however, when you send us an email, you may be providing certain information that personally identifies you (“Personal Information”), such as your name, mailing address, phone number, email address, and other personal information and interests.

#### Personal Information

- We may use your Personal Information to send you important notices, such as communications about purchases and changes to our terms, conditions, and policies.
- We may also use Personal Information for internal purposes such as internal record keeping, data analysis, and research to help us improve our products, Services, and advertising.
- We may use your Personal Information to administer any account you may have with us, and to customize the services we provide to you and other users.

#### Non-Personal Information

- We may collect information regarding user activities with our Services, which may be aggregated and used to help to improve our products, Services, and advertising. Aggregated data is considered non-personal information for the purposes of this Privacy Policy.

### Confidentiality and Security

Culinary Farms takes precautions, including administrative, technical, and physical measures, to safeguard your Personal Information against loss, theft, and misuse, as well as against unauthorized access, disclosure, alteration, and destruction. Except as set forth in this Privacy Policy, Culinary Farms will not share your Personal Information with third parties, unless such disclosure is necessary to: comply with a court order or other legal process; protect our rights or property; enforce our Terms of Service; or if we determine that for purposes of national security, law enforcement, or other issues of public importance, disclosure is necessary and appropriate.

## **Maintaining Personal Information**

We maintain a procedure to help you confirm that your Personal Information remains correct and up-to-date. We will retain your Personal Information for the period necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required or permitted by law.

## **How We Use Cookies**

Our products, Services, and advertisements may use cookies and other similar technologies. These technologies help us better understand user behavior, tell us which parts of our services and applications are being used, what Services have been visited, and facilitates and measure the effectiveness of advertisements. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

We may use cookies and other technologies when you use our website, and other online services. Our goal in these cases is to make your experience with us more convenient and personal.

We may also gather some information automatically and store it in log files. This information includes IP addresses, browser type and language, Internet Service Provider, referring and exit pages, operating system, date/time stamp, and click-stream data. We use this information to understand and analyze data; to administer the website and other services; to learn about user behavior; and to gather demographic data about our user base as a whole.

We may use this information in our marketing and advertising. We treat information collected by cookies and other technologies as non-personal information. However, to the extent that IP addresses or similar identifiers are considered Personal Information by local law, we also treat these identifiers as Personal Information. Similarly, to the extent that non-personal information is combined with Personal Information, we treat the combined information as Personal Information for the purposes of this Privacy Policy.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of our website and other services.
